- The classification server runs as a Microsoft Windows service driven by XML calls over sockets (which makes it easy to integrate with other Operating Systems).

LICENSE AGREEMENT

UCLASSIFY SERVER ENTERPRISE END USER LICENSE AGREEMENT

You should carefully read the following terms and conditions before using the uClassify Server, along with any accompanying documentation or tools (the uClassify Server, documentation and its tools will be referred to herein as the "Server").

Your use of the Server means that you accept these terms and conditions. If you do not agree with these terms and conditions, then uClassify is unwilling to license the Server to you, and you should not use the Server. By installing, downloading, copying, or otherwise using the Server, you acknowledge that you have read these terms and conditions, understand them, and agree to be bound by them. If you do not agree to these terms and conditions, you are not authorized and may not use the Server.

1. DEFINITIONS.

(a) 'Application' means any application that was made using the Server.

(b) 'Commercial' means any selling, bartering, trading or otherwise exchanging for consideration or compensation of any sort, whether payment, royalties, etc.

2. LIMITATIONS. The Server is copyrighted and protected by law and international treaty. The user is granted a non-exclusive license to use the Server on four computers, for any legal purpose, at a time. This is a license, not a transfer of title, and you may not, nor permit anyone else to, (a) modify the Server or use it for any commercial purpose or public display, performance, sale or rental; (b) decompile, reverse engineer, or disassemble, modify, or create derivative works based on the Server or the documentation in whole or in part; (c) remove any copyright or other uClassify proprietary notices; or (d) transfer the Server to another person. You agree to prevent any copying of the Server.

2a. ENTERPRISE LICENSE LIMITATIONS. The license expires 1 year after the time of purchase and can be installed on 4 computers. The license entitles getting started support + 1 month and minor upgrades. The source code for the classification server is not included in the Server. The GUI seen on uClassify.com is not included. You are allowed to build an unlimited number of classifiers with the Enterprise Licensed Server. You don't have to give uClassify any credits. The license grants you the right to distribute the Application without any royalty to uClassify.

3. OWNERSHIP. The Server is copyrighted proprietary material of uClassify, and may not be copied, reproduced, modified, published, uploaded, posted, transmitted, or distributed in any way, without uClassify's prior written permission. Except as expressly provided herein, uClassify and its suppliers do not grant any express or implied right to you under any patents, copyrights, trademarks, or trade secret information of uClassify or its suppliers.

4. TERMINATION OF THIS LICENSE. uClassify may terminate this license at any time if you are in breach of any of these terms and conditions of use. Upon such termination you must and agree to immediately destroy all copies of the Server.
